### **53rd Annual General Assembly (AGA): The 2022 Interline Celebration Quarantine Rules Ended**

On 21 March the government of Indonesia lifted all quarantine rules for fully-vaccinated visitors to end two years of border closure. This follows measures taken by its neighbour countries in easing entry restrictions as Southeast Asia moves past the worst of the Omicron variant of COVID-19. The government expanded its quarantine-free travels to the rest of the country following a successful two-week trial of the programme in Bali, Batam and Bintan islands where infections have remained low. A Zoom video conference call will now be arranged with the tour operator, who will be handling the AGA logistics, to ensure negotiations with the hotels and ground handling companies are resumed to ensure everything is completely in order for our AGA and tours to proceed smoothly.

#### **Dates**

As a reminder, dates and locations of the 53rd AGA and tours in Indonesia are as follows: pre-AGA tour: Java Grand Tour, 9–16 October 2022; venue: departs from Yogyakarta, concludes in Bali. 53rd Annual General Assembly (AGA): The 2022 Interline Celebration, 16–21 October 2022; venue: Bali. Post-AGA tour: Land of the Dragons and the Lesser Sunda Islands, 21–25 October 2022; venue: departs from Bali and concludes in Bali. The brochures that were issued in 2020 are being amended for 2022 and will be issued once the package costs have been confirmed.

#### **Post-AGA Tours: Land of the Dragons and the Lesser Sunda Islands**

Thank you to all members who advised it was their intention to take the post-AGA tour immediately following the AGA. The response indicates that there will be enough members participating on the tour to secure the deluxe Phinisi boat for back to back excursions exclusively for WACA. The first of two groups on the tour will commence in the town of Senggigi and then take the deluxe Phinisi boat. The second group will commence the tour on the deluxe Phinisi boat and then transfer to the town of Senggigi.

#### **Africana Festival — KwaZulu Natal Highlights Tour**

Regretfully, the Africa, Indian Ocean Islands and Middle East Region has found it necessary to cancel the Africana Festival due to be held from 19–25 April.
