V3R2K6 , or given to a current director by December 1, 2016 The position of President is automatically filled by the 2016 Vice President. the following positions are open for nominations. (assistants required also!)

**VICE PRESIDENT:** The Vice President will assist the resident in coordinating the general affairs of the club and acts as liaison between the executive and various appointed committees.

The Vice President automatically takes over the position of President for the following year, therefore this is a two year term position.
